1. The main purpose of compiling this Monthly Bulletin is to show the general situation of Changhua county. It is intended to provide data for decision-making.
2. The measure units used in this Monthly Bulletin are of metric system and the currency unit is N.T.\$\$. If the figures in the table are long, we lift the unit count 5 and higher fractions as units and disregarding the rest. Therefore the total number doesn't always coincide with the detail number.
3. The following symbols are used for tables:
  - ”-” means no figures.
  - ”...” means figures not yet available.
  - ”0” means figure is below half a unit.
  - ”--” means figure provided are meaningless.
4. The figures given in this issue may not agree with the corresponding figures in the previous issue. The figures given in this issue is correct.

## 二、商業登記

本縣108年7月底之商業登記家數及資本額分別為37,497家及82億5,008萬元，與上月底比較，分別增加0.26%及0.10%。

各行業中以批發及零售業21,004家，約占56.02%最多，製造業4,827家，約占12.87%次之。而資本額亦以批發及零售業33億1,200萬元，約占40.15%最多，製造業16億3,688萬元，約占19.84%次之。

### 三、工廠登記

本縣108年7月底工廠登記家數為10,876家，與上月底比較，登記家數增加0.42%。

各行業中以金屬製品製造業4,098家，約占37.68%最多；塑膠製品製造業1,050家，約占9.65%次之。

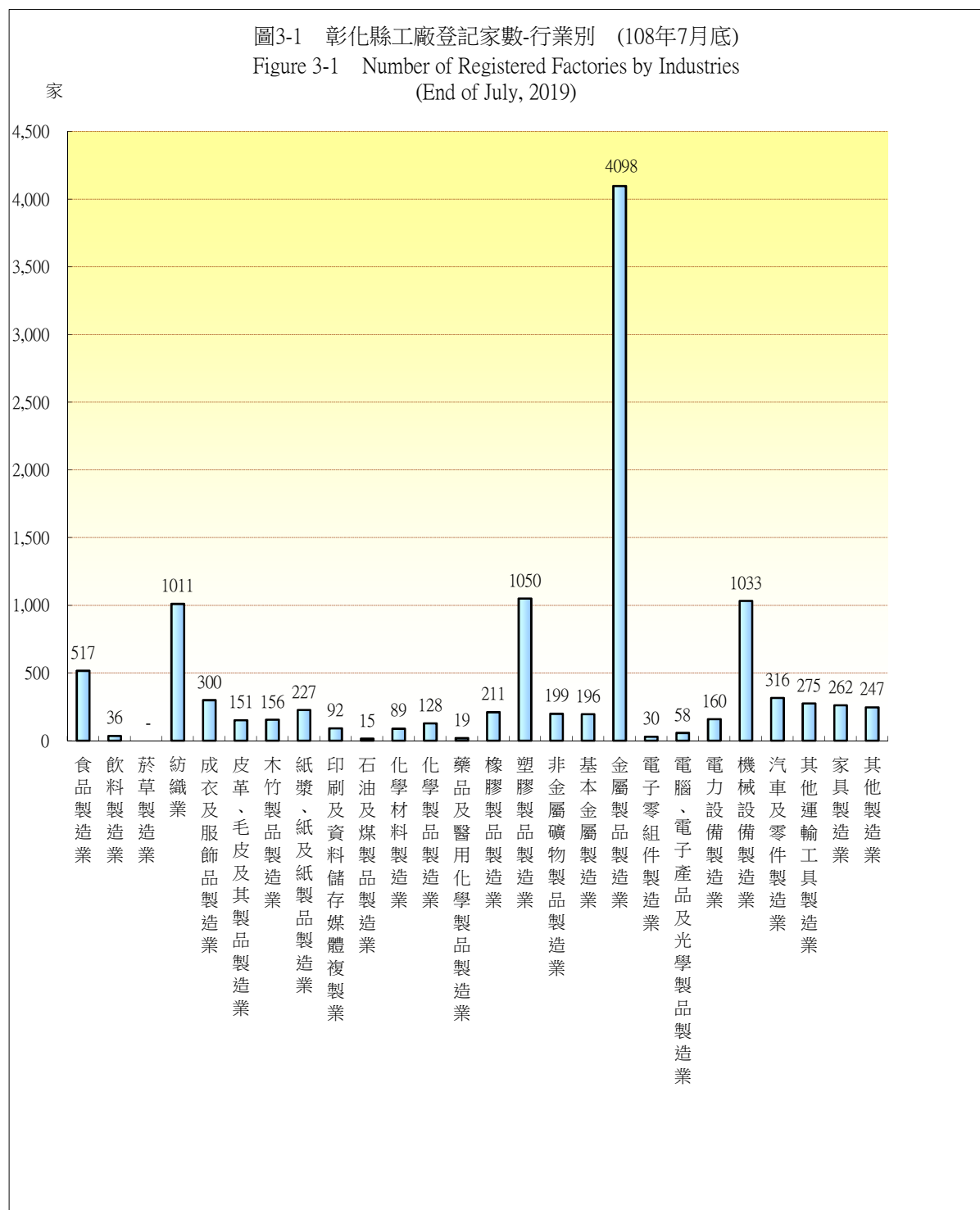


圖3-2 彰化縣工廠登記家數  
Figure 3-2 Number of Registered Factories

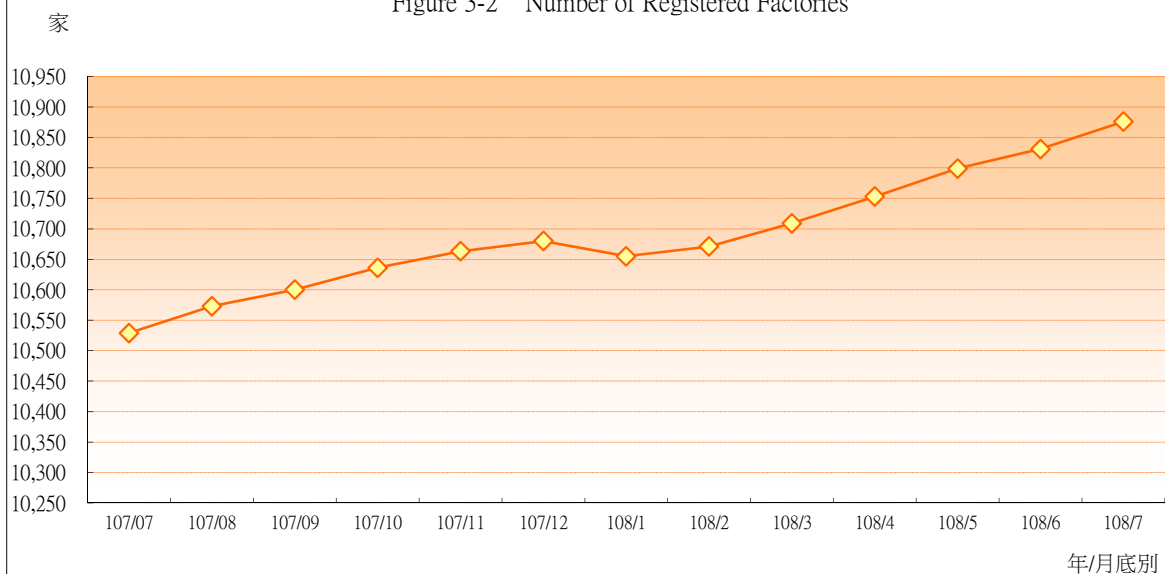
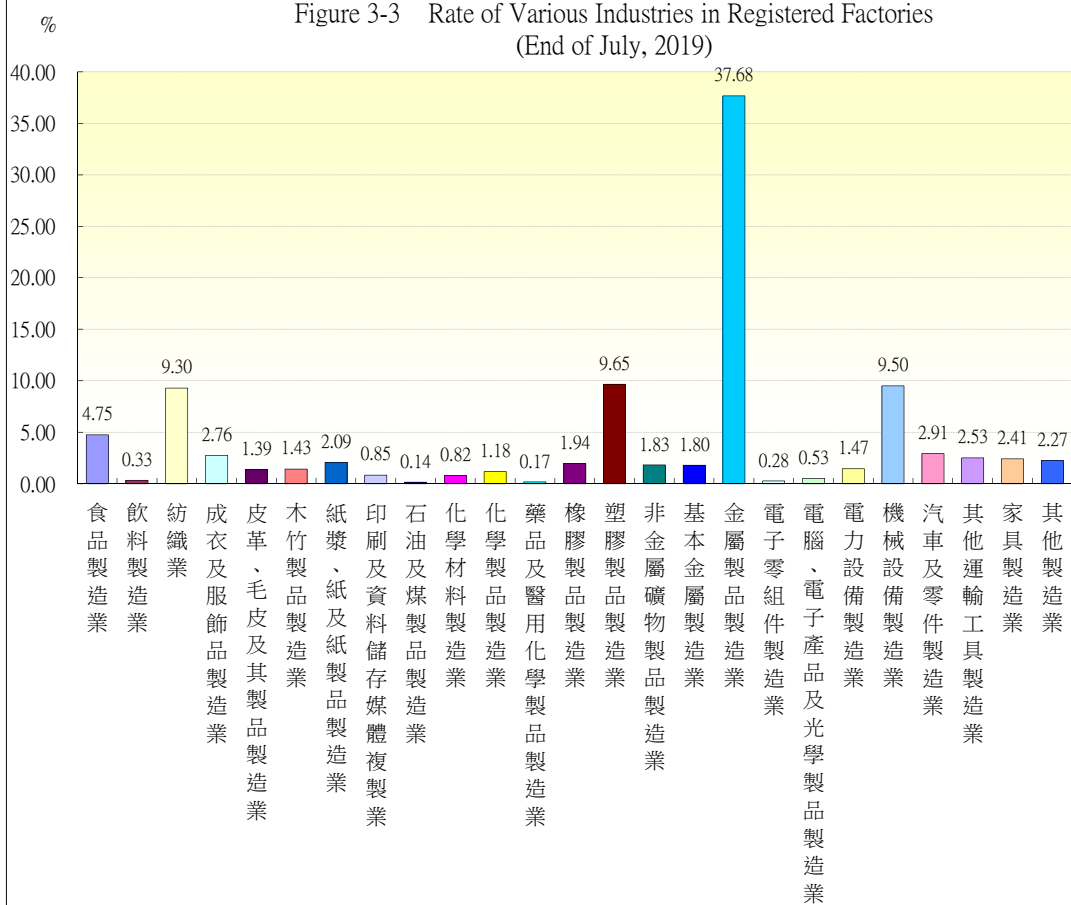


圖3-3 彰化縣工廠登記家數各行業所占比率 (108年7月底)

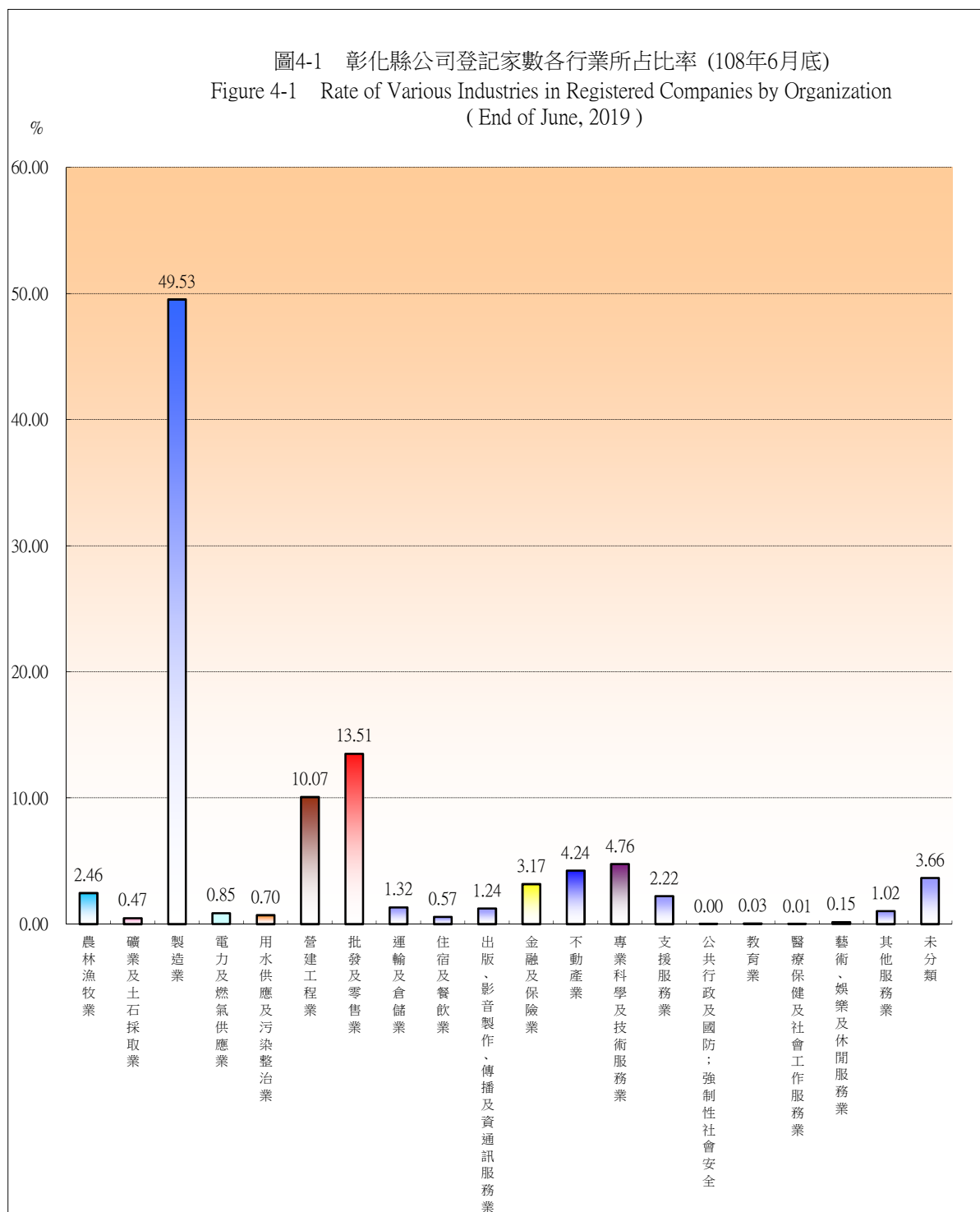

圖4-2 彰化縣公司登記家數

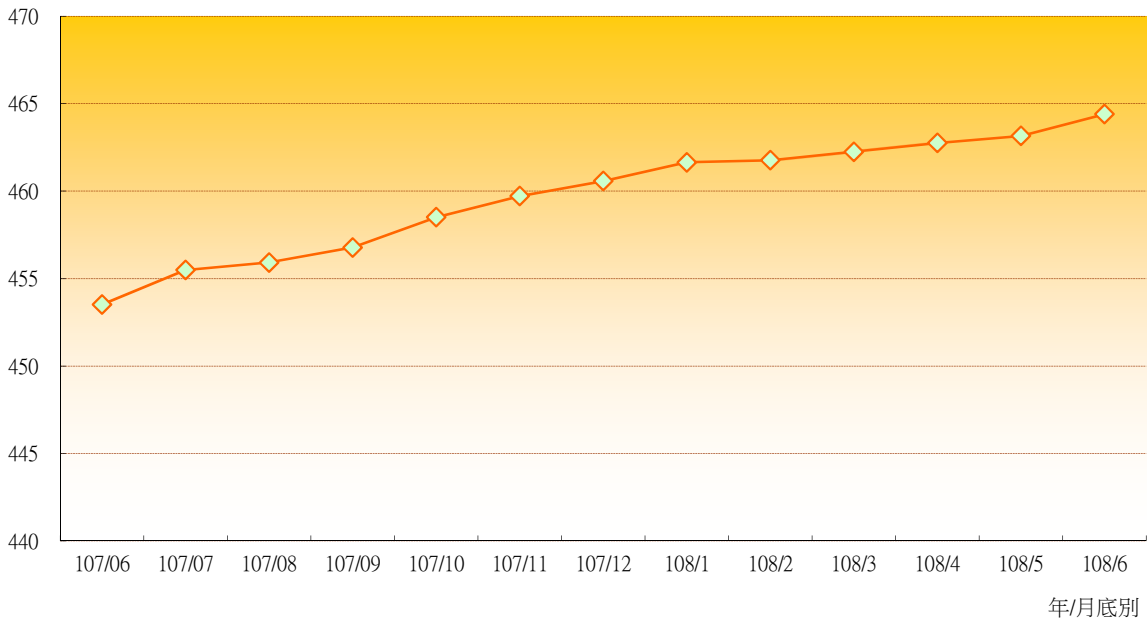
Figure 4-2 Number of Registered Companies by Organization

## 九、稅捐徵收

108年本縣縣稅徵收截至7月底止之實徵淨額為87億2,182萬元，累計徵收率（累計實徵淨額/累計分配預算數）為114.03%，實徵淨額較上年同期減少2億9,033萬元(或3.22%)。累計實徵淨額以使用牌照稅38億2,631萬元，約占43.87%最多；房屋稅28億3,322萬元，約占32.48%次之；土地增值稅15億9,578萬元，約占18.30%再次之。
